Public parks led the quarter at \$140,000, followed by public schools at \$109,855.62 and performing arts at \$74,500.

81 requests • \$742,344.32

The second-largest quarter of the year. Performing arts accounted for \$192,668.81 and public schools for \$107,717.74.

August 20, 2026

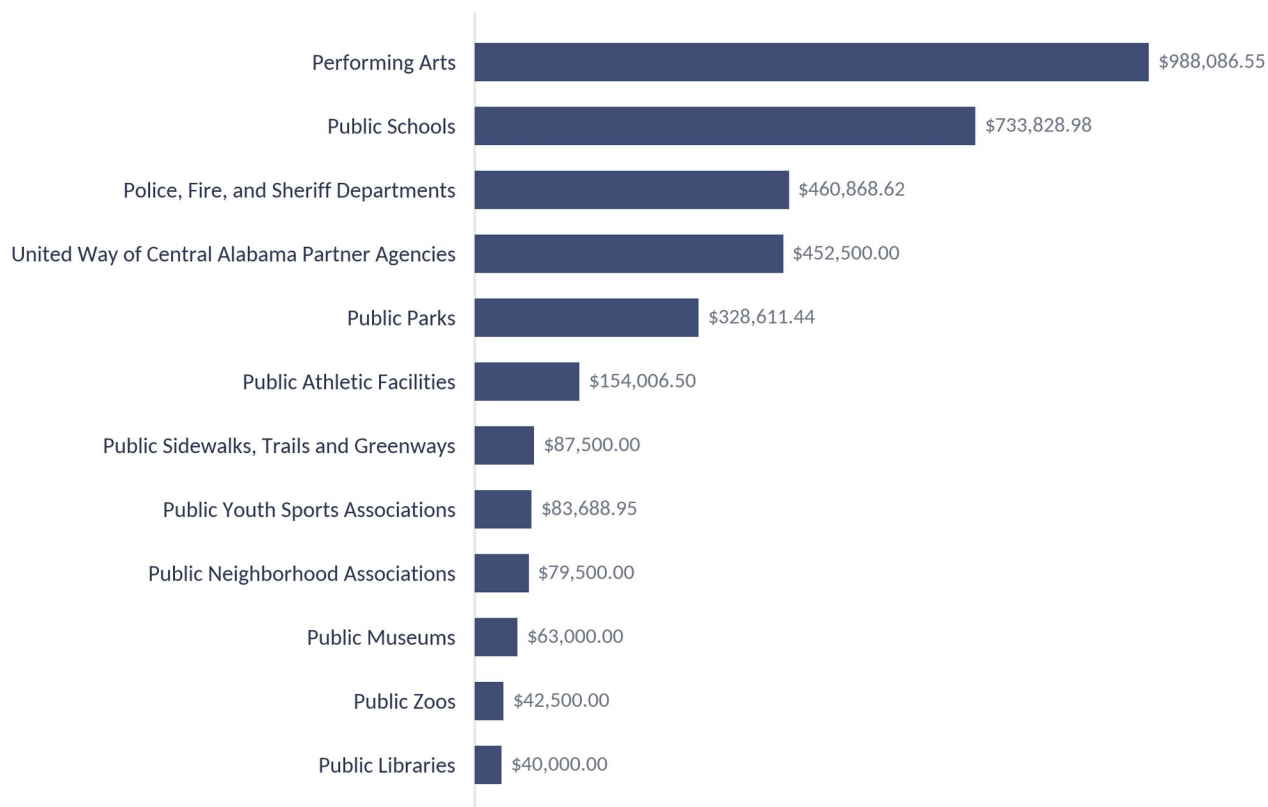
7 requests • \$58,211.24

LOOKING AHEAD

2026 – 2027 Allocations

The Fund was awarded \$3,600,000 for the 2026–2027 fiscal year. After adding accrued interest and accounting for administrative and legal fees, \$3,460,675.25 will be allocated in equal shares between the Senate and House delegations.

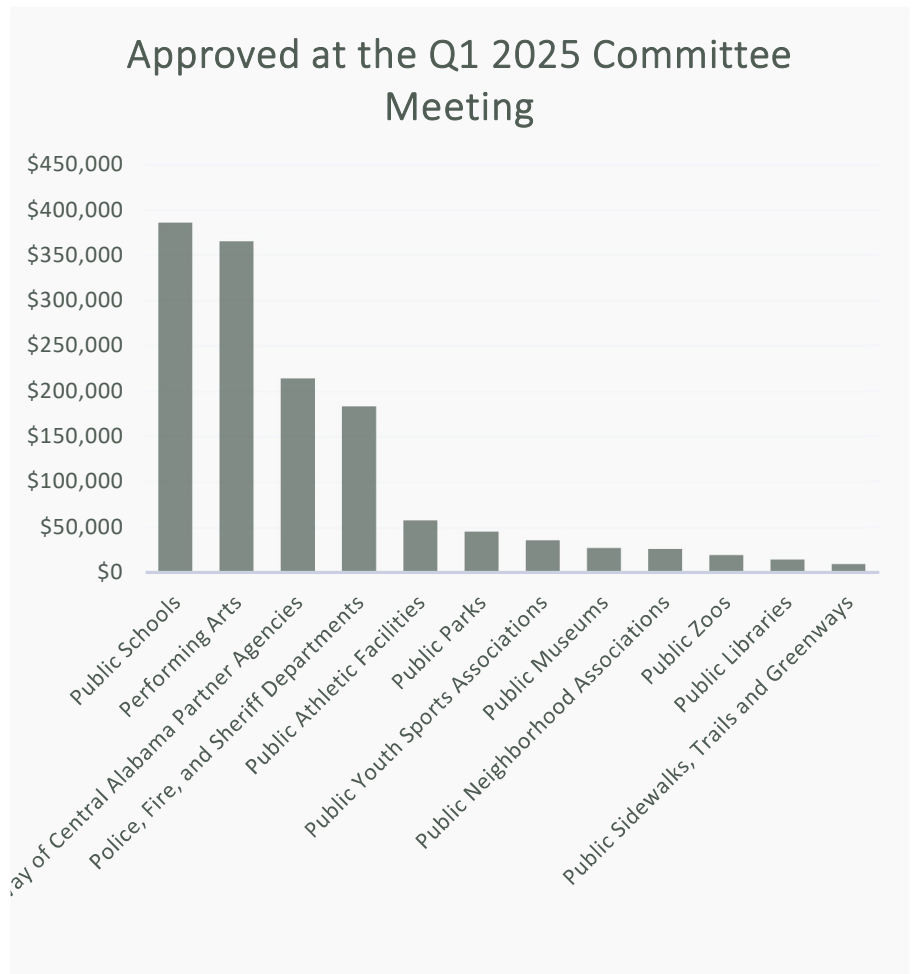

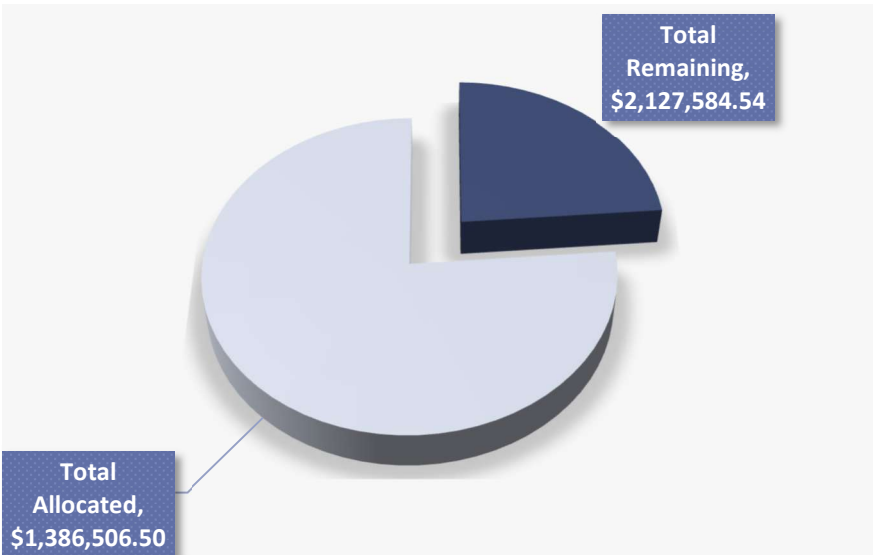

ANNOUNCEMENTS

This past quarter has been a tremendous success for the Jefferson County Community Service Fund, completing 170 grant requests and providing \$1.3 million in support to the community.

On Thursday, November 13th, 2025, the Fund held their annual fall committee meeting. Prior to the meeting, delegates were authorized to submit emergency grant requests to United Way Partner Agencies to assist individuals impacted by the temporary holding of SNAP funds. In response, the committee approved 10 emergency requests, totaling \$95,000 in aid, alongside the standard grants submitted by delegate members.



SNAP funding were distributed to several vital organizations, including:

- Community Food Bank of Central Alabama
- Salvation Army – Birmingham Area Command
- Pathways
- Birmingham Urban League

These efforts reflect the JCCSF's ongoing commitment to ensuring essential resources reach those who need them most.

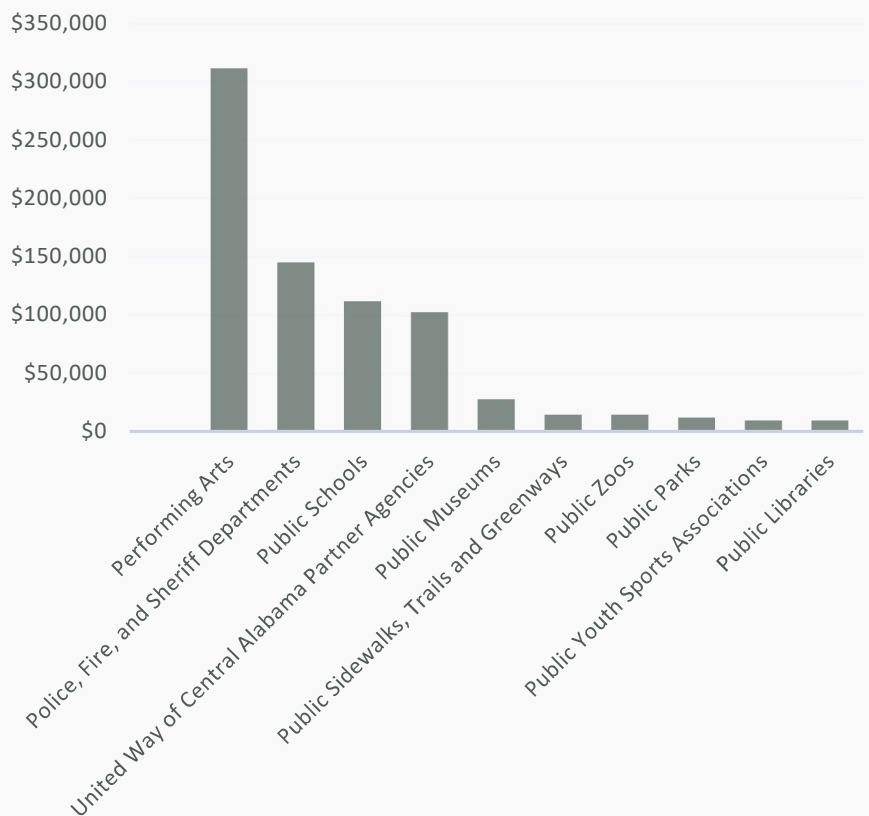

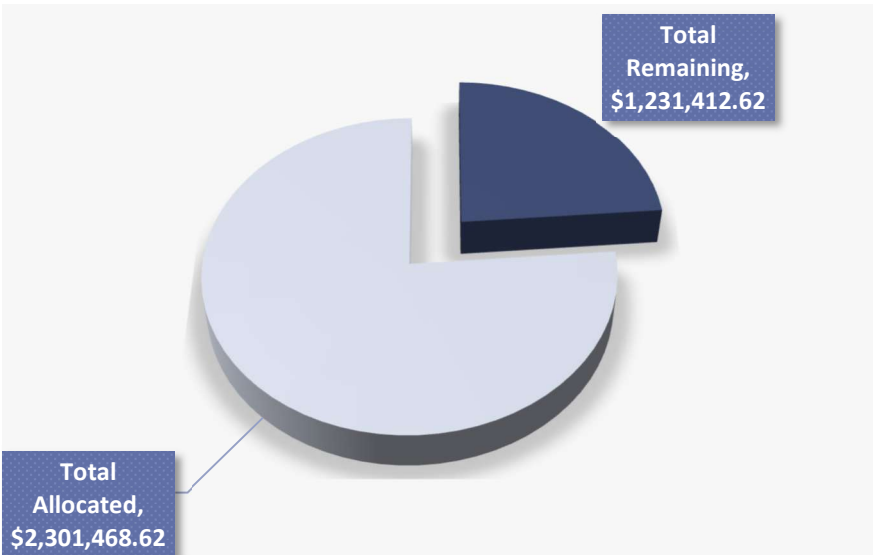
